RE: Summary of Telephone Research on the Sound Transit and RTID Roads & Transit package

Key Findings

Puget Sound residents continue to think that traffic and transportation issues (51%) are the most important problems facing the region in an open-ended question. A strong majority (61%) support the current Roads & Transit package language in an uninformed test; which includes the cost of \$16.5 Billion but does not include householded costs.

Support drops (49%) after voters hear the typical household costs early in the survey.
Support returns to a strong majority (63%) after voters hear a description of the major components of the package.

Support is marginally improved (up to 66% Support) when respondents are read a series of positive messages, and marginally decreased (down to 61% Support) when respondents are read a series of negative messages.

METHODOLOGY

Written and Conducted by Moore Information and EMC Research: April 1 – 4, 2007
N = 800 registered voters in the RTA District, \pm 3.5 point margin of error
Results reflect the voter population distribution of the RTA District
Results can be projected to the entire voting population of the RTA District


The initial test of the package is supported by a strong majority (61%), and is presented on an uninformed basis, with no persuasive messaging as follows:

- “A transportation package has been proposed that would increase the sales tax by 6/10 of 1%, and the car license tab by 8/10 of 1%. It would fund \$16.5 Billion dollars in road, highway, and mass transit improvements in Pierce, King, and Snohomish Counties”.

While still uninformed about the package elements, respondents’ support drops below a majority (49%) when they are told what the package will cost the typical household:

- “This package will cost the typical household \$150 in additional sales tax each year, plus \$80 in license tab tax for every \$10,000 of your car’s value.”

Summary of Support for Transportation Package



Support rebounds (63%) when voters are read the major components of the package (no persuasive messaging). It remains at this level after positive (66%) and negative (61%) messaging about the package.

The chart below shows the percentage of all voters who favor the specific package items when asked (this chart includes only the top scoring items across the ST District).
